Be it enacted by the Town Board of the Town of Prattsville as follows:

SECTION 1. Section 4.A. of Local #2 of 1989 of the Town of Prattsville, commonly known as the Prattsville Halloween Curfew Law shall be and hereby is amended with the following additional requirements added at the end of such section:

“It shall be unlawful for any minor to on any street, highway, road, parking lot or public or private area (unless consented to by the owner thereof) after 8:30 p.m. on October 31st of any year (commonly known as Halloween) until 7:00 a.m. November 1st of any year unless said minor is accompanied by his or her parent or guardian.”

SECTION 2. This local law shall take effect immediately when it is filed in the Office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.
