"It shall be unlawful for any minor to on any street, highway, road, parking lot or public or private area (unless consented to by the owner thereof) after 8:30 p.m. on October 31<sup>st</sup> of any year (commonly known as Halloween) until 7:00 a.m. November 1<sup>st</sup> of any year unless said minor is accompanied by his or her parent or guardian."
