That Sec. 3.2 of Local Law No. 1-1987 of the Town of Prattville establishing the areas of special flood hazard be amended as follows:

3.2 BASIS FOR ESTABLISHING THE AREAS OF SPECIAL FLOOD HAZARD

The areas of special flood hazard have been identified by the Federal Emergency Management Agency in a scientific and engineering report entitled "Flood Insurance Study Town of Prattville, New York, Greene County" dated November 16, 1982 with Flood Insurance Rate Maps enumerated on Map Index No. 360296 0001-0020 dated May 16, 1983.

The above documents are, hereby, adopted and declared to be a part of this local law and are filed at the Town Clerk's Office.

Local Law No. 2 of the year 19 89

A local law providing for special curfew for Halloween in Town of Prattville

1. TITLE: This law shall be known as Special Curfew for Halloween in the Town of Prattville.
2. DECLARATION OF PUBLIC PURPOSE AND LEGISLATIVE INTENT: It is the declared purpose of the Town of Prattville to maintain the public order and to protect the health, safety and well being of the community. Recognizing that in recent years, the evening of October 31st, commonly known as "Halloween" has been the occasion of unwarranted and unlawful public disruption, mischief and vandalism, it is the intent of this Local Law to prevent the occurrence of such public disruption on Halloween or any day or night close to Halloween. Further recognizing that much of the disruption, mischief and vandalism has been caused or is related to a number of young people congregating within the Town without any lawful or legitimate purpose, it is the declared legislative intention of this Local Law to prevent said mischief, disruption and vandalism on Halloween and on such other dates surrounding Halloween as is necessary to maintain the public order.
3. DEFINITIONS:
 - A. MINOR: As used herein minor shall mean and refer to any person under the age of 18 years.
 - B. PARENT/GUARDIAN: As used herein, the term parent or guardian shall mean and refer to the natural or adoptive parent or grandparent or legal guardian of any minor.
4. UNLAWFUL CONGREGATION:
 - A. It shall be unlawful for any minor to be on any street, highway, road, parking lot or public or private area (unless consented to by the owner thereof) after 10:00 p.m. on October 31st of any year (commonly known as Halloween) until 7:00 a.m. November 1st of any year unless said minor is accompanied by his or her parent or guardian.
 - B. The Supervisor of the Town of Prattville may extend the curfew set forth herein to any other night or nights preceding or subsequent to Halloween as deemed appropriate by the Supervisor for the purpose of maintaining the public order.

5. PENALTIES: Any person found guilty of violating this Local Law shall be guilty of a violation and subject to the penalties set forth in the Penal Law of the State of New York.

6. SEVERABILITY: In the event that any word, phrase or part of this Local Law shall be declared unconstitutional, the same shall be severed and separated from the remainder of this Local Law and shall not affect the remainder of said Local Law which shall remain in full force and effect.

7. EFFECTIVE DATE: This Local Law shall take effect immediately upon filing with the Secretary of State of the State of New York.
