ARTICLE 1. TITLE AND PURPOSE

A. Title

This Local Law shall be known and may be cited as "The Subdivision Regulation Enforcement Local Law of the Town of Prattville, New York".

B. Enacting Clause

The Town Board of the Town of Prattville in the County of Greene, pursuant to Section 268 of the Town Law, hereby ordains, enacts and publishes this Local Law.

C. Purpose

The purpose of this Law is to enforce the Town of Prattville Subdivision Regulations adopted by the Town of Prattville Planning Board on July 18, 1966 and approved by the Town Board of Prattville on September 8, 1966.

D. Application of Regulations

1. No land in the Town of Prattville shall be subdivided except in conformance with the Town of Prattville Subdivision Regulations.

2. No Building Permit shall be issued to any person, firm, or corporation for the construction of any building on property which has been subdivided after the effective date of this Local Law without subdivision approval by the Planning Board of the Town of Prattville.

3. For the purpose of this Local Law, the term subdivided shall mean the subdivision of lands as defined in the Town of Prattville Subdivision Regulations.

**ARTICLE II. ADMINISTRATION AND ENFORCEMENT**

**A. Enforcement**

This local law shall be enforced by the Building Code Enforcement Officer.

**B. Issuance of Building Permit**

No Building Permit or Certificate of Occupancy shall be issued by the Building Code Enforcement Officer, and no permit or license for any purpose shall be issued by an official of the Town of Prattsville if the same would be in conflict with the provisions of this Local Law until the applicant has provided sufficient documentation that the property upon which the building is to be constructed meets with the requirements of the Subdivision Regulations of the Town of Prattsville. Sufficient documentation includes any of the following:

1. A copy of the Town of Prattsville, Planning Board approved subdivision plat that includes the applicant's property.
2. A certification from the Greene County Clerk, the Clerk of the Town of Prattsville Planning Board or other appropriate official, that the subdivision plat has been approved by the Town of Prattsville Planning Board.
3. A copy of the deed or other appropriate proof that the property was a lot of record as of the effective date of this Local Law/Ordinance.

**ARTICLE III. MISCELLANEOUS**

**A. Violation**

A violation of this Subdivision Regulation of the Town of Prattsville and or this Local Law is an offense punishable by a fine not exceeding \$250.00 or by imprisonment for not more than six (6) months or both. Violations of the Local Law shall be deemed misdemeanors and for such purposes only, all provisions of law relating to misdemeanors shall apply to such violations. Each week's violation shall constitute a separate additional violation.

**B. Separate Validity**

If any article, subarticle, paragraph, clause, or other provision of the Subdivision Regulations of the Town of Prattsville and or this Local Law shall be held invalid, the invalidity of such article, subarticle, paragraph, clause, or other provision shall not affect any of the other provisions of this Local Law.

**C. Effective Date**

This Local Law shall take effect on June 15, 1987.
