The purpose of the meeting is appoint a new Code Enforcement Officer, and address the Ambulance Contract agreement with Ashland.

The Town Board received a letter of resignation from Donald Rion as Code Enforcement Officer. A motion was made by Councilperson Peckham and seconded by Councilman Martin to accept the resignation from Donald Rion as Code Enforcement Officer.

The original agreement with Ashland Ambulance services was for a 33% cost commitment. Rich Tompkins, Ashland's Supervisor changed Prattsville's percentage figure to 41% commitment. It will be determined that Prattsville's percentage will be 41%, Lexington's percentage will be 30% and Ashland's percentage will be 29% of the cost to operate the Ambulance service. The contract if signed will become effective immediately and be in effect until the end of December.

A motion was made by Supervisor Cross and seconded by Councilperson Peckham to approve and sign the Ashland Ambulance contract as it stands.
