LOCAL LAW NO. 2 OF 2023

TOWN OF PRATTSVILLE LOCAL LAW ESTABLISHING SENIOR CITIZEN TAX EXEMPTION PURSUANT TO SECTION 467 OF THE REAL PROPERTY TAX LAW

Be it enacted by the Town Board of the Town of Prattsville, in the County of Greene, as follows:

SECTION 1. TITLE.

This local law shall be known as the "Senior Citizen Tax Exemption Establishment Law of the Town of Prattsville, Greene County, New York."

SECTION 2. AUTHORITY.

This local law is adopted pursuant to Real Property Tax Law §467. All terms, definitions and conditions of such statute shall apply to this local law.

SECTION 3. PURPOSE.

It is the purpose and intent of this local law to set the maximum exemption allowable for the senior citizen's exemption, as set forth by the Real Property Tax Law of New York State, § 467, Subdivision 1, paragraph (b), subparagraphs (2) and (3).

SECTION 4. LEVEL OF EXEMPTION.

The Town of Prattsville hereby adopts as the maximum level of income for persons eligible for the within exemption as \$34,000.00 (Thirty Four Thousand Dollars). The "sliding scale" provisions of New York Real Property Tax Law §467 are also hereby adopted.

SECTION 5. SEVERABILITY.

If any clause, sentence, paragraph, section or part of this Local Law shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to said clause, sentence, paragraph, section or part of this Local Law.

SECTION 6. INCONSISTENT LAWS.

All Local Laws or parts of Local Laws inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION 7. EFFECTIVE DATE.

This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with Municipal Home Rule Law § 27.
