A local law Authorizing The Town of Prattsville to Enter Into a

SECTION 1.

In order to insure the availability of general medical services for the residents of the Town of Prattsville, and thereby provide for the safety, health and well-being of its' residents, the Town of Prattsville may contract with the Margaretville Memorial Hospital for the establishment of a community health clinic in the Town of Prattsville, to operate at least two days per week, wherein general medical services for residents of the Town of Prattsville shall be provided at a reduced fee schedule.

SECTION 2.

The Town of Prattsville may pay for such clinic establishment costs, including costs associated with renovation of suitable facilities within the Town, a sum not to exceed \$3000.

SECTION 3.

This local law shall become effective immediately upon its filing in the Office of the Secretary of State.
