TOWN OF PRATTSVILLE LOCAL LAW #1 OF 2018 GRIEVANCE DAY ESTABLISHMENT

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF PRATTSVILLE

SECTION 1. TITLE AND PURPOSE

This Local Law of the Town of Prattsville, Greene County, New York shall be known as the "Grievance Day Establishment Law."

The purpose of this Local Law is to establish the day for hearing by the Board of Assessment Review of the Town of Prattsville of grievances addressed to real property tax assessments on an alternate date as permitted by Real Property Tax Law §512 (1-a).

SECTION 2. APPLICABILITY AND DURATION

This local law shall be applicable to all grievances addressed to assessment of lands within the Town of Prattsville and shall be in effect indefinitely or until modified or repealed by the Town Board of the Town of Prattsville.

SECTION 3. GRIEVANCE DAY

All grievances addressed to assessments of real property within the Town of Prattsville shall be heard by the Board of Assessment Review of the Town of Prattsville on the first Wednesday following the fourth Tuesday of May of each year.

SECTION 4. EFFECTIVE DATE

This Local Law shall take effect immediately when it is filed in the Office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.
