LOCAL LAW #1 of 2022
TOWN OF PRATTSVILLE
THREE-MONTH EXTENSION OF MORATORIUM ON
APPROVAL OF SITE PLAN REVIEW APPLICATIONS

Be it enacted by the Town Board of the Town of Prattsville as follows:

SECTION 1. Local Law number 3 of the year 2021 of the Town of Prattsville entitled "Local Law Imposing A Temporary Town-Wide Six-Month Moratorium On Site Plan Review" and each of its terms, conditions, and definitions shall be and hereby are extended for a period of 3 months from the date of the enactment of this local law.

SECTION 2. This local law shall take effect immediately when it is filed in the Office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.
