Section 1. Title and Purpose: This local law shall be entitled "Local Law #1 of 2013 Amending the Water Service Law (Local Law #1 of 1993)."

Section 2. Amendments:

- A. **Section 5.00 Payment for Water Service**, subparagraph (a) shall be amended and hereby shall be: (a) Schedule of Water Rates: The Town Board shall establish, from time to time and by Resolution following a public hearing, the water rates to be paid by customers. Water Rates may be obtained from the Water District upon request.
- B. Appendix "A" is hereby repealed.

Section 3. Enactment: This local law is enacted pursuant to the requirements of the General Municipal Law and the Local Home Rule Law of the State of New York and shall become effective upon filing with the Secretary of State.

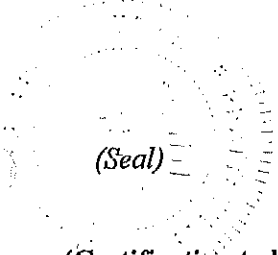
